JSP-SIG Panel in 2010 ATJ seminar

After seeing the success of JSP SIG panel and increasing interest in JSP at the ATJ Seminar last year, I would like to suggest that we form another panel at the next ATJ seminar. The 2010 ATJ Seminar will take place on March 25th in Philadelphia, PA. The guidelines for the SIG-sponsored session proposal are the same as last year, which are:

- The SIG proposal should be submitted at the same time as the individual and other panel proposals.
- The SIG proposal will be reviewed by the Seminar committee at the same time as the regular proposals. (This implies that the SIG-sponsored panel does not receive priority over other regular proposals. It is possible that the SIG-sponsored panel may be rejected.)

Under these conditions, I would like to set up the procedures for preparing a proposal for the JSP-SIG panel as follows. This is the same process we followed last year.

- 1) Call for Papers within JSP-SIG in advance.
- 2) JSP-SIG Panel selection committee, comprised of JSP-SIG members who do not submit paper proposals in JSP-SIG panel, will select papers for the panel by October 11 and notify the authors as soon as they can, no later than within a week. (This way, those who may not be a part of JSP-SIG panel can submit their proposal as a regular paper to ATJ Seminar directly).
- 3) JSP-SIG Panel selection committee members, selected panelists, and the coordinator of JSP SIG work together to write a proposal for JSP SIG Panel and submit it to ATJ.

Obviously, this is a collaborative effort that requires members' active involvement. Thank you in advance for being a part of this operation.

(5) Member in the Spotlight: Dr. Robert A. Russell

Robert Russell is an Associate Professor of Japanese at Brigham Young University in Provo, Utah. He recently completed his second term as Chair of BYU's Asian and Near Eastern

Languages Department, and is looking forward to spending more time in teaching and research after a much-needed sabbatical leave.

In addition to general Japanese skills courses, Russell teaches courses in Business Japanese, as well as in Japanese linguistics and language teaching methodology. Most of his scholarly research has been concentrated in Japanese second language acquisition and attrition, and in CALL materials design and development. He has also recently begun an applied research project in the area of Japanese for business and other special



purposes, and has begun to develop case studies for use in advanced Business Japanese classes. Most of his recently published work is in the area of JSL attrition, including, among other publications, "Lexical Maintenance and Attrition in Japanese as a Second Language," in Lynne Hansen, ed., *Second Language Attrition in Japanese Contexts*, pp. 114-141, Oxford University Press (1999); "L2 Japanese Syntactic Attrition," in Ritva Laury, Gerald McMenamin, Shigeko Okamoto, Vida Samiian, and Karumuri V. Subbarao, eds., *Perspectives in Linguistics: Papers in Honor of P. J. Mistry*, pp. 311-326, Indian Institute of Language Studies (2003); and "Functional Analyses of the Acquisition and Attrition of *-wa* and *-ga* in Japanese as a Second Language," in S. Kuno, S. Makino, and S. Strauss, eds., *Aspects of Linguistics: In Honor of Noriko Akatsuka*, pp. 311-339, Kurosio Shuppan (2007).

Over the years, Russell has enjoyed serving with wonderful colleagues in the profession, having served two terms on the ATJ Board of Directors, for a period of time as Linguistics Editor of the *Journal of the Association of Teachers of Japanese* (now *Japanese Language and Literature*), and as a member of the ATJ–US-Japan Foundation Fellowship Committee, among other assignments. He has served as Director of the Japan Internship and Study Abroad Program at BYU, has been involved in needs analysis and curriculum design for Business Japanese, and has given numerous presentations and workshops for teachers of Business Japanese, most recently as part of a series of national CIBER business language workshops co-presented with Dr. Yuki Matsuda (University of Memphis) and hosted by the Wang Center for International Business at the University of Memphis. He has also been the Principal Investigator of large materials development grants from the U.S. Department of Education, the Nippon Television Network Cultural Society together with Fujitsu Ltd., and the Air Force Office of Scientific Research.

In his personal life, Russell enjoys traveling and spending time with his wife, Candy, and their five children and 13 grandchildren. Although none of his children has followed in his academic footsteps, one of his sons is currently a T-38 jet instructor pilot (an assignment his father held

swhile in the U.S. Air Force many years ago) and will soon be flying F-16s in East Asia. For fun, Russell is an avid tennis player, tries to stave off attrition in his golf, chess, and Arabic language skills, and is eagerly trying to acquire Spanish as a second language (demonstrating the truth of the adage that 'it's tough to teach an old dog new tricks').
